## **DEFINITIONS & ADDITIONAL INFORMATION FOR NEW APPLICANTS**

## MEMBERSHIP S

The membership in this association shall be on the basis of a final acceptance by the Board of Directors of a membership application signed by the applicant and sponsored by one member of this Association. Acceptance by the Board shall be by majority affirmative vote of a quorum.

The following membership categories shall constitute the membership of the Association:

- A. **Intra-State Marketer** means any person, partnership or corporation whose principal business location is within the State of New York and whose sales consist of LP Gas, equipment, appliance or service to ultimate consumers and are made substantially within the State.
- B. **Multi-State Marketer** means any person, partnership or corporation regardless of principal business location that engages in any of the following: sells LP Gas, equipment, appliances or service to ultimate consumers within New York State, from one or more business locations, but in addition conducts similar operations in other states and is a member of the National Propane Gas Association.
- C. **Associate Member** means any individual, partnership or corporation engaged in the sale of products and/or services to marketers.
- D. **Individual Member** means any person employed or retired from a member firm.
- E. **Honorary Membership** may be conferred on any individual recommended to the Board of Directors and approved by the Board by 2/3 vote of a quorum.
- F. **Lifetime Membership** may be conferred by the Board on members of the Association recommended to the Board of Directors and approved by the Board by 2/3 vote of a quorum.

## **VOTING**<sup>8</sup>

The right to vote is limited to Intra-State, Multi-State and Associate members in good standing. One (1) representative is to be designated for this purpose by the person, partnership or corporation at the time of application for membership. This designation may be changed, as necessary, upon notification from the above member. Vote may be cast by written proxy or each referenced member may appoint an alternate representative authorized to act in the absence of the designated representative.

**NPGA** defines a Retail locations as follows: "A location that is staffed and open to the public to pay a bill, order gas, or conduct other business"

(This added July 5, 2017: NPGA prorates dues as follows: Joining in month: April -75%, May -67%, June -59% July -50%, August -42%, September -33%. New York Propane Gas Association prorates dues to members by month.

- <sup>B</sup> We ask about number of bulk plants as NPGA uses this to assess their dues. NPGA defines a Bulk Plant as follows: "A facility where the primary functions is to store LP-Gas prior to further distribution. LP-Gas is received by cargo tank vehicle, railroad tank car, or pipeline, and then distributed by portable container (package) delivery, by cargo tank vehicle, or through gas piping."
- <sup>M</sup> New members require sponsorship by an NYPGA member. If you do not know any NYPGA members, NYPGA will help find a sponsor for your company
- N For intrastate marketers, NYPGA collects dues from the marketer and remits the entire NPGA dues amount to NPGA on behalf of the marketer. NYPGA typically remits dues to NPGA in June or July of the year.
